



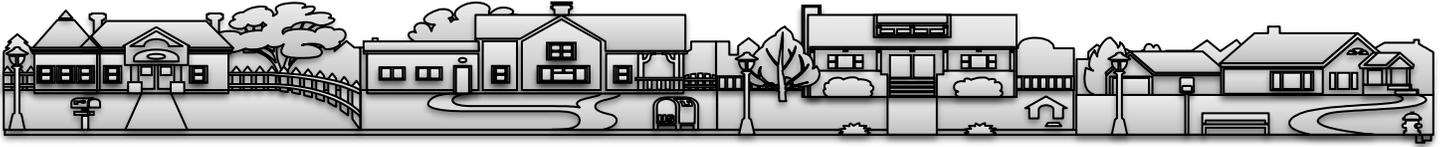

General Municipal Law 239 Review

- a. #21-002– Village of Watkins Glen – Zoning Amendment
 - Kristin provided an overview of the zoning amendment and explained what the impetus behind it was.
 - Brian Kenney made a motion to recommend the approval of the Zoning Amendment for the Village of Watkins Glen Code seconded Peggy Tomassi
 - Mike Bergen asked why they limited the number of people per home to 10 people, and a discussion ensued.All in favor vote. Motion passed.
- b. #21-003– Village of Watkins Glen – ZBA Area Variance – 600 Division St
 - Kristin provided an overview of the requested area variance and the change from STR to Bed and Breakfast
 - A discussion occurred around the difference between STRS and Bed and Breakfast
 - Mike Bergen made a motion to recommend the ZBA Application be returned to the Village of Watkins Glen as “Local Concern Only” due to the limited change in use and destiny of the project seconded by Justin Boyette. All in favor vote. Motion passed.
- c. #21-003– Village of Watkins Glen – ZBA Area Variance – 356 N. Glen Ave
 - Kristin provided an overview of the requested area variance and went through a series of maps outline the parcel sizes around the project.
 - A discussion was had about the future of housing and the impact of parcels being split in the future.

- Brian Kenney made a motion to recommend disapproval of the ZBA Application
 - Based on the following: The Village recently updated their zoning law to and lowered the minimum lot size from 20,000sf to 15,000sf with the intent of maintain lower density on larger lots. As such the planning commission recommends disapproval of the creation of two non-conforming lots due to the impact on the potential community character.

Seconded by Harriett Ferrell. All in favor vote. Motion passed.

d. #21-003– Village of Watkins Glen – ZBA Area Variance – 600 Division St

- Brain Grose of Fagan Engineers presented and overview of the project. Kristin discussed the initial areas of recommendation that were made to the Town of Cayuta.
 - Brian noted that trees will be planted along the west and north side of the property, but no additional vegetation is being proposed at this time.
- Justin Boyette made a motion to recommend approval with the following recommendations
 1. Recommend continuing the fence along the west side of the property all the way to the end of the property line
 2. Considering including some vegetation within the site.

Seconded by Brain Kenney. 7 ayes – 1 abstain (Mike Bergen). Motion passed.





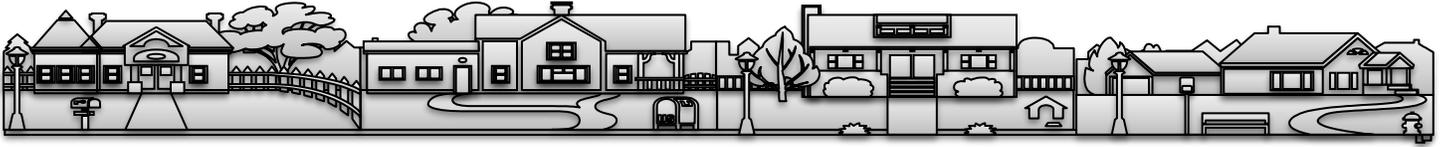

General Municipal Law 239 Review

- a. #22-010- Town of Dix – Special Use Permit – 3465 Beaver Dams-Moreland Road
 - Kristin provided an overview of the project to create a 3,000sf pond on a residential property.
 - Discussion was had about what the proposed use of the pond would be and if it met the required setbacks.
 - Alice Learn made a motion to recommend the approval of the special use permit, seconded by Norma Burris. All in favor vote. Motion passed.

- b. #21-007a - Town of Dix – Special Use Permit – 1239 Duval Road
 - Kristin provides an overview of the proposed changes to the previously approved site plan, including
 - The project owner/Applicant changed the solar modules and racking from a fixed tilt to single-axis tracking (SAT) system to increase electricity production. This switch in racking system and row orientation changed the original approved fence line and increased the overall system footprint by ± 7.5 acres.
 - In addition, the utility entrance and overhead interconnection are now proposed along Beaver Dams-Moreland Road (Town road), where previously they were approved on Duvall Road (private road) as a single entrance.
 - Peggy Tomassi made a motion to recommend the approval of the special use permit, seconded by Norma Burris. All in favor vote. Motion passed.

- c. #22-011 – Village of Watkins Glen – ZBA – Use Variance – 1 First Street
 - Kristin provided an overview of the requested use variance for a medical clinic in the Lakefront Zone. The Village Zoning allows for office-medical clinics only in the Village Center, Neighborhood, and Industrial Districts. The building was previously a medical clinic; however, it has been closed for more than a year and can no longer be considered a nonconforming use.
 - A Discussed the proposed use remaining compatible with the community character and the minimal impact that would be felt by granting the proposed use variance.
 - Norma Burris motioned to recommend the approval of the special use permit seconded by Peggy Tomassi. All in favor vote. Motion passed

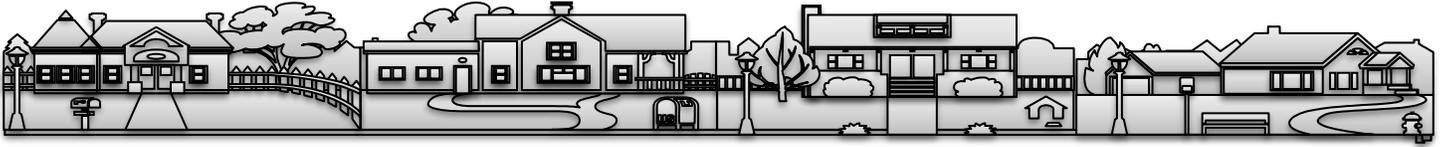

1. The Towns of Orange and Cayuta have put moratoriums on solar development.

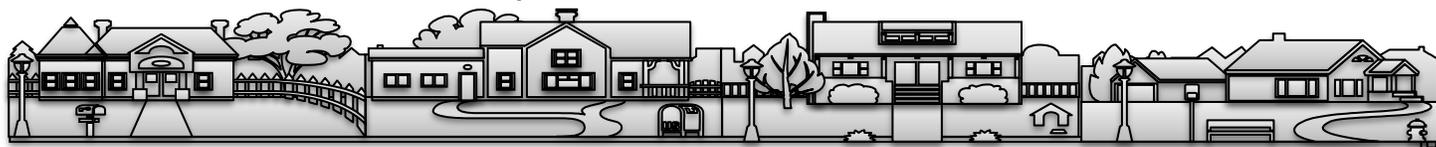

- a. #22-012 – Town of Montour – Site Plan Review - 4245 County Road 14 – Solar Farm
 - Joe Tassone, Jr. and Nick Schupp, representatives of AboveGrid Solar and Renovus Solar respectively, presented their site plan for a solar farm on 4245 County Road 14. They discussed advantages to the site location and answered questions from board members clarifying construction impact and community benefits.
 - Brian Kenney motioned to approve the site plan review, seconded by Norma Burris. All in favor vote, 8-eyes. Motion passed.

- b. #22 -013 – Village of Watkins Glen – Special Use Permit – 40 Fairgrounds Lane
 - Kristin presented the Special Use Permit and highlighted where discrepancies exist in the application, including when the “existing sites” were constructed.
 - A discussion took place around the proposed project.
 - Harriet Ferrell motioned the following recommendations:
 - A fully developed site plan in accordance with Section 42.4 of the zoning law that includes, at a minimum, the following information: the accurate number of spaces, size, and location of each space, as well as the overall circulation plan of the 18 spaces to ensure proper access of emergency vehicles.

- Provide documentation to the owners have coordinated and pursuant to NYS Department of Health, Public Health Law Section 225, Part 7, Subpart 7-3 Campground

- Motion seconded by Norma Burris. All in favor vote, 8-ayes. Motion passed.
- c. #22-014 – Village of Watkins Glen – Special Use Permit – 229 S. S. Jackson St

 - Brian Kenney motioned to approve a special use permit with the following recommendations:
 - Site Consider the addition of signage marking the driveway and the limited sight distance at the intersection with S. Jackson Street.
