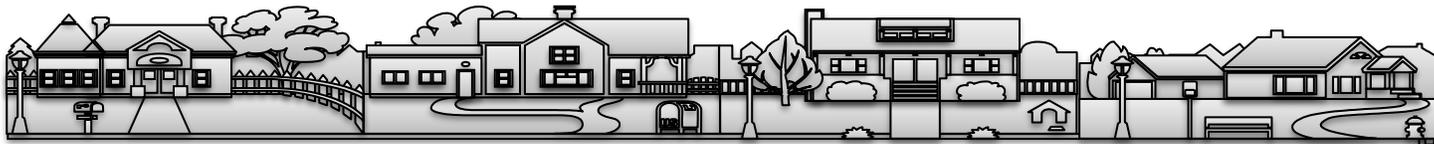

- a. #19-001 – Town of Dix – Subdivision (2915 Beaver-Dams Moreland Rd)
 - Kristin provided a summary of the project. Both parcels will remain agriculture.
 - Ted Marks made a motion to approve this subdivision, seconded by Mike Bergen. All in favor vote, 12-aye. Motion passed.

- b. #19-002 – Village of Watkins Glen – ZBA (806 N. Decatur Street)
 - Kristin described that the circumstances that led to the need for a use variance including that a coffee shop is not listed in the current Watkins Glen Zoning Use Chart.
 - The coffee shop is already operating at this location and would like to expand the wholesale component of the business.

 - The expansion would be primarily for the wholesale of coffee beans which would be shipped or delivered off site.

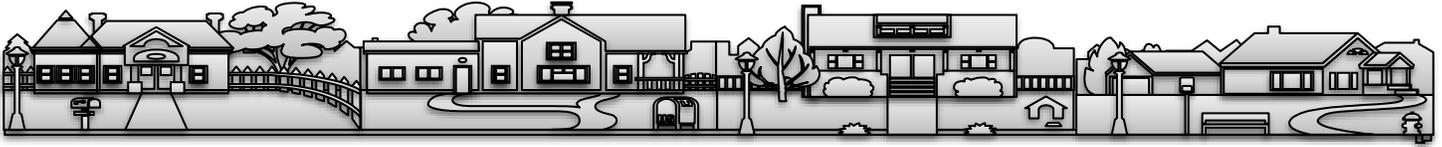

Introduction of New Members: Introduced Kyle Colunio who will be the representative from the Village of Montour Falls, Sarah Agan who will represent the Town of Montour and Alicia Janke who will represent the Village of Odessa.

Opportunity for Public Comment: None

Review and Approval of Minutes: Matt Schamel made a motion to approve the minutes from the January Planning Board Meeting,. Seconded by Joe Sevier. All in favor vote, 10-aye. Motion passed.

General Municipal Law 239 Review

- a. Amanda Postma of Renovus Solar provided an overview of her company and the goals behind Renovus's Solar Farm projects. She noted that they encourage community input and chose the sites based on property ownership, proximately to 3-phase electric, and prefer not to locate them within prime agricultural land.
 - They have discussions with SHPO and DEC about each solar installation
 - The panels have a warranty of 25 years – the life span is 30+ years
 - Renovus is responsible for decommissioning.
- b. A general discussion occurred in relation to #19-003 and 19-004 in regard to the Town of Dix Updated Solar Law which was passed in 2018 without following the General Municipal Law 239m review process.
 - There is a general concern that in a few places the updated law is inconsistent with the general Town of Dix Zoning law which the solar law is part of.
 - The Solar law should be updated to address and resubmitted through the proper boards to ensure that all projects are reviewed using the same criteria.

- Motion was made to send a letter outlining the board's recommendations to the Town of Dix Board and Planning Board by Joe Sevier and seconded by Alice Learn. All in favor vote, 10-aye. Motion Passed.

- c. #19-003 – Town of Dix – Special Use Permit (1550 Russel Hill Road)
 - Ms. Postma provided an overview of the proposed solar installation.
 - It was noted that this project is located within soils of state-wide importance but not prime agricultural land and is not currently in agriculture production.
 - Matt Schamel made a motion to approve this special use permit seconded by Harriett Ferrell. All in favor vote, 10-aye. Motion passed.

- d. 19-004 – Town of Dix – Special Use Permit (3130 County Rt 16)
 - Ms. Postma provided an overview of the proposed solar installation.
 - It was noted that this project is located within soils of state-wide importance but not prime agricultural land and is not currently in agriculture production.
 - Matt Schamel made a motion to approve this special use permit seconded by Alice Learn. All in favor vote, 10-aye. Motion passed.

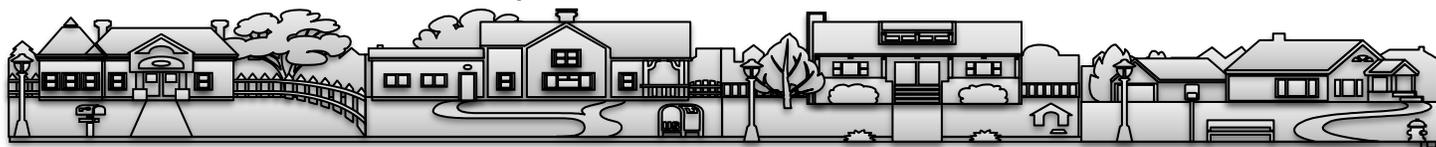

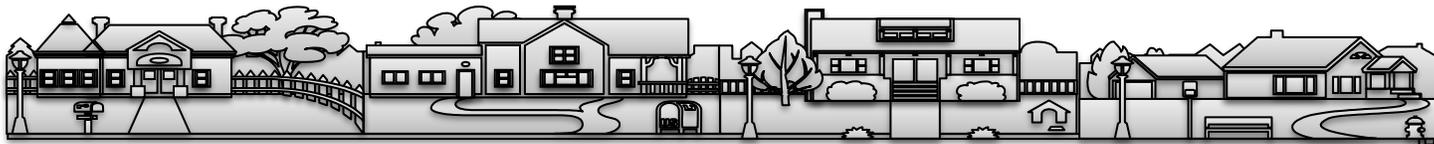

Review and Approval of Minutes: Ted Marks made a motion to approve the minutes from the February Planning Board Meeting, seconded by Alice Learn. All in favor vote, 13-aye. Motion passed.

General Municipal Law 239 Review

- a. #19-008 – Town of Reading- Subdivision Law
 - Kristin VanHorn described this was a small update from the Subdivision Law that was reviewed as part of #17-010 in September 2017 and reviewed updates.
 - Dave Stamp made a motion to approve the subdivision law, seconded by Sarah Agan. All in favor vote, 13-aye. Motion passed.

- b. #19-009 – Village of Watkins Glen – ZBA (Famous Brands Sign)
 - Bill Pylpciw indicated that the current signage on the building is inline with the village zoning and should continue to be encouraged.
 - Alyssa Wixson expressed concern about other business wanting a similar sign and how it would change the downtown area and that we should encourage moving toward the design guidelines
 - Ted Marks pointed out that the zoning law isn't perfectly clear on this issue, and in the next zoning update the entire signage section should be revised.
 - Ben Stamp said we should support the efforts of the code enforcement and not make exceptions to the intent of the design guidelines.
 - Bill Pylpciw made a motion to deny this variance request, seconded by Alyssa Wixson. All in favor vote, 13-aye. Motion passed.

- c. #19-010 – Town of Dix – Special Use Permit (Watkins Glen International)
 - Kristin VanHorn reviewed the proposal as it only relates to the off-site camping portion of the proposal and not the planning commissions thought as they pertain to the Woodstock event.
 - A discussion of safety and liability for the off-site area was had.
 - There will not be any campfires or grilling allowed in these areas
 - Harriett Ferrell made a motion to approve the special use permit, seconded by Dave Stamp. All in favor vote, 13-aye, 2-opposed, Mike Bergen and Ted Marks noting the impact on the agricultural fields. Motion passed.

- d. #19-011 – Town of Dix -Special Use Permit (2870 County Rt 16)
 - Jonatha Meade and Dawn Aprile provided an overview of the phase 1 and 2 of the project.
 - Mike Bergen asked if the driveway entrance will be wide enough to accommodate cars on trailers to come in and out. – Developers noted they would take the into consideration during phase 2.
 - Ted Marks made a motion to approve the proposed special use permit, seconded by Ben Stamp. All in favor vote, 13-aye. Motion passed.

- e. #19-012 – Town of Dix – Subdivision (Beaver Dams-Moreland Rd)
 - Review the proposed subdivision
 - Matt Schamel made a motion to approve the proposed subdivision with the recommendation that the access agreement is in place before final approval, seconded by Harriett Ferrell. All in favor vote, 13-aye. Motion passed.

- f. #19-013 – Town of Dix – Subdivision (2655 Van Zandt Hollow Rd)
 - Review the proposed subdivision
 - Ted Marks made a motion to approve the proposed subdivision, seconded by Joe Sevier. All in favor vote, 13-aye. Motion passed.

- g. #19-014 – Village of Montour Falls – Site Plan Review (116 N. College Ave)
 - Matt made the motion to deem this an incomplete application and make the following recommendations to be address, seconded by Mike Bergen. All in favor vote, 13-aye. Motion passed.
 - Lot Coverage: The proposed project covers 62% of the lot, when the parking and drive areas are counted. This would require an area variance, as the zoning only allows for 50% coverage.
 - Building Siting: Section 160-30 of the Zoning Law provides guidance for the new construction along Route 224. It is the recommendation of the Planning Commission that the building is flipped to the north side of the lot, so the front of the building is along Route 224 and the parking lot is at the back of the building. Ensure that the overall gateway quality is maintained.
 - Stormwater: The proposed project description and site plan does not provide or acknowledge any stormwater prevention measures. This needs to be addressed.
 - Water/Septic: It needs to be clarified how the water and septic will be provided for on the site. It was indicated in the SEQR form that proposed project will connect to a private water supply. The location of the proposed or existing well is

not drawn on the site plans. If a septic system is required this need to be addressed as part of the site plan, as the proposed project as drawn does not have a sufficient space to a septic system.

- Salt Storage Building: What will be stored in the building and how will the salt be handled. If it is loose or the bulk storage of salt accommodations need to be made to ensure that it will not seep into the ground.

Staff Report: Kristin provided an update on past projects.

Planning Commissioner – Community Update:

- Ted Marks discussed the STC Regional Planning Conference and the sessions he attended. Ted encouraged other Planning Commissioners to attend in the future and recommended that the conference fee be paid by the County.

- There was a question about a project in the Town of Reading, and if the Planning Commission had reviewed it. Kristin said that she would pull the referral and review what was approved vs. what is being constructed and update the commissioners at their next meeting.

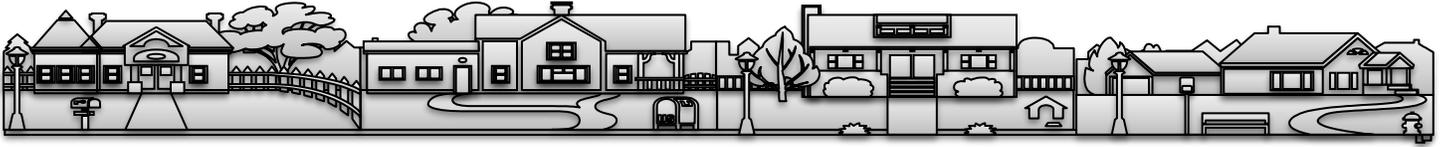

 - The commission noted that this area is primarily single-family homes and would have a very limited impact on the community character and is not out of line with the Village Comprehensive Plan.

- b. #19-016– Town of Dix – Subdivision (1465 Russell Hill Road)
 - Kristin VanHorn explained how the lots would be subdivided, and a discussion on the parcel layout was had.

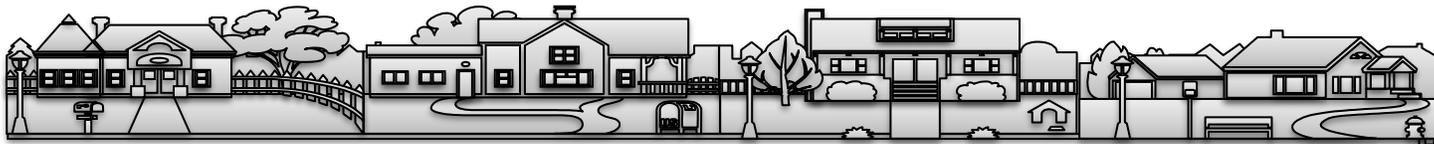

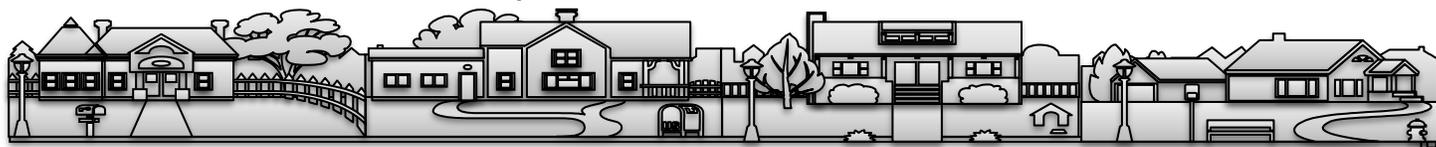

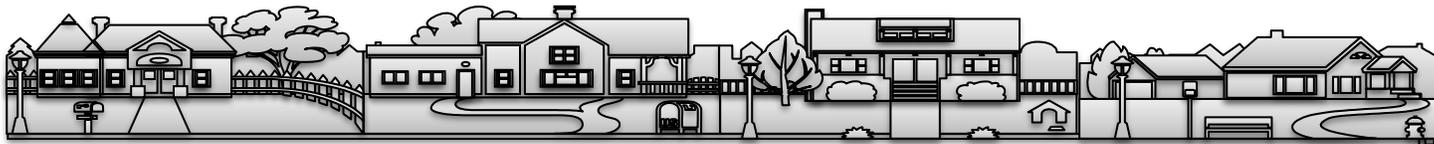

 - Dave Adams (the architect for the project) reviewed the project, addressing questions about the easements on the site, the potential lighting fixtures.
 - o The materials for the buildings will match the surrounding buildings with brick on the bottom, the top will be a white/cream-colored.

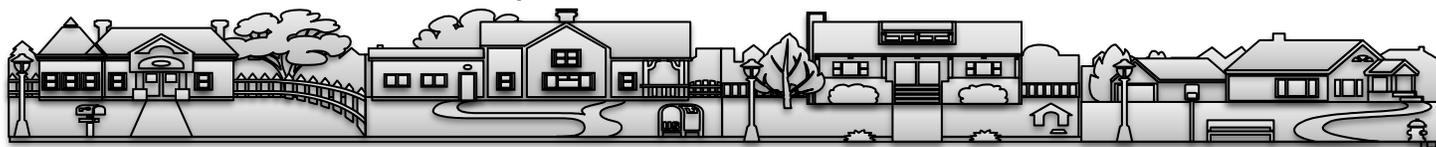

Review and Approval of Minutes: Mike Bergen made a motion to approve the minutes from the September Planning Board Meeting, seconded by Alice Learn. All in favor vote, 12-aye. Motion passed.

General Municipal Law 239 Review

- a. #19-027 –Town of Dix-Subdivision Review (2111 NYS Route 414)
 - Kristin reviewed the project and explained how the three new parcels would be created. There is no proposed change of the uses existing on the property and it is expected to remain agriculture.
 - Alice Learn made a motion to approve the proposed subdivision, seconded by Joe Sevier. All in favor vote, 12-aye. 1- abstain (Mike Bergen) Motion passed.
- b. #19-028 – Village of Watkins Glen – Area Variance, ZBA (515 E. 4th Street)
 - Ms. Kim from BRR Architecture presented the proposed area variance for the use of “Knockout Orange” on the frame for a parking structure on the west side of the Walmart Building to be used for grocery pickup. Ms. Kim explained that the proposed color “Knockout Orange” should be considered an earth tone color because is the same color as the “sunset, pumpkins, fall leaves, and Georgia Clay”. Further she explained the orange color was consistent with their corporate brand and would aid in the wayfinding on the site.
 - There was a question about why this required a variance, but the painting of the actual Walmart Building did not.
 - The Village of Watkins Glen changed their Zoning Law since the Walmart was painted.
 - Ben Stamp asked if matching the color on the building was a vital component of the project.

- Harriett Ferrell noted that with good signage people could still find their way to the grocery pick up
- Bill Pylpciw noted that because the end wall is already the “Knockout Orange” it wouldn’t be difficult to find your way to the grocery pick up area.
- Mike Bergen and Ted Marks shared they didn’t feel that it was a decision that should be made at the County Planning Commission level, but by the Village.
- There was a general discussion about the Village’s design guidelines and the goals/ character the Village is trying to achieve by implementing such strict design guidelines. It was noted that in communities where design guidelines have clearly worked they have stayed strong to them.
- Bill Pylpciw made a motion to recommend the Village of Watkins Glen ZBA deny the area variance, seconded by Harriett Ferrell. All in favor vote, 8-aye, 3 opposed (Jan Arcangeli, Mike Bergen, Rick Hendrick. 1- abstain (Ted Marks) Motion passed.

Staff Report:

- New Digital Billboard within the Town of Dix
 - Several Commissioners have inquired about the new digital billboard located just outside the Village of Watkins Glen line in the Town of Dix, and why it did not require review by the Planning Commission.
 - Kristin explained the Town Board changed the zoning law in regard to signs and did not follow proper NYS Law, by completing the SEQR Review or sending the zoning law amendment to the County Planning Commission for review.
 - Kristin did speak with the Town of Dix Administrator, Kristi Pierce and explained why it is so important zoning changes are sent to the county and that the Town follow GML, Environmental Conservation Law for Zoning Amendment in order to prevent lawsuits that would be costly to the Town
 - It was recommended that the Planning Commission send the Town the same letter that was sent after a similar situation happened with the changes to the Town’s Solar Law. It was further recommended that the letter be sent to every board member, the supervisor, and town attorney and followed up on at a Town Board Meeting.
- Kristin reported that there will be a public information meeting on the Two Village Regional Strategic Plan on November 18 at 5pm at the Watkins Glen Community Center.

 - Kristin will follow up with the Chair of the Planning Board on the issue, and if necessary, send another letter about procedure.

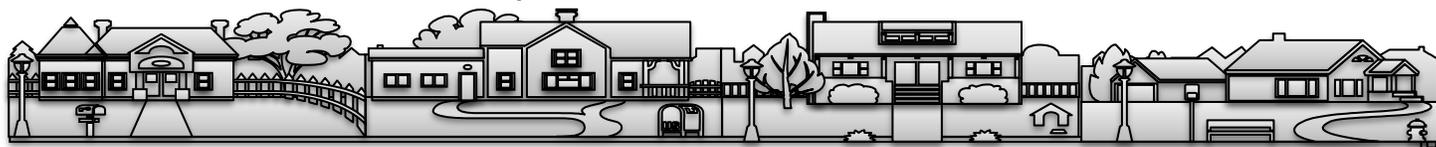

General Municipal Law 239 Review

- a. #19-029 – Village of Watkins Glen – Site Plan Review (515 E. 4th Street)
 - Kristin provided an update on the color change as a result of last months variance request. Otherwise no changes have been made to the Site Plan.
 - Ben Stamp made a motion to approve the proposed site plan, seconded by Alice Learn. All in favor vote, 13-aye. Motion passed.
- b. #19-030 – Town of Dix – Special Use Permit (2419 County Rt 17)
 - Kristin provided an overview of the project and noted that this was only giving approval to using the existing garage, and should a new building be constructed the applicant will need to go through the Special Use Permit process again.
 - There was a question about the impact on the neighbors, the commissioners agreed that it would be minimal.
 - Ben Stamp made a motion to approve the proposed special use permit, seconded by Joe Sevier. All in favor vote, 13-aye, Motion passed.
- c. #19-014A – Town of Dix – Special Use Permit (2419 County Rt 17)
 - Mr. Atwood reviewed the project noting the there would be 6 apartments, and they included an engineered stormwater retention pond to address drainage concerns.
 - There was a question about the building materials and colors, Mr. Atwood stated that each apartment would most likely be a different color.

- Kristin outlined a concern about lot size differences between the map/survey and the calculations used for lot coverage. The drawings state a 50% lot coverage but based on the parcel size it should be 55%.
 - Mr. Atwood noted that there is an additional “unclaimed” parcel between his property and the neighboring parcel that is being used in that calculation.
 - Ted Marks made a motion to approve the proposed site plan with the following recommendation
 - The lot size dimensions and coverage need to be addressed and brought into compliance or a zoning board of appeals applications needs to be made and approved.
 - Encourage the implementation of design guidelines around the color and materials used for the project.
- seconded by Ben Stamp. All in favor vote, 12-aye, 1-abstain (Harriett Ferrell) Motion passed.
